Election of LML Board Officers: Jim made the motion to elect Fran for the office of chair. Seconded by Emily. All in favor. Ken made the motion to elect Melanie for the office of secretary. Seconded by Fran. All in favor. Kim made the motion to elect Jim for the office of treasurer. Seconded by Fran. All in favor. Fran appointed Jim to facilitate today's Trustee meeting.

Secretary's Report: Sigh made the motion to accept the February 9, 2021 meeting minutes. Seconded by Emily. All in favor.

Librarian's Report: Amy presented her suggestions for reopening. Plans to reopen in June are being considered. More information will be presented at our April meeting. Amy also shared with the Board proposals for the future of the library. The Board will examine and take into consideration these suggestions during future meetings.

New Business:

- *Capital Reserve Fund Goals* – The Board reviewed and discussed which projects, using the capital reserve funds, could be completed this year. After much deliberation, Sigh made the motion to use monies from the reserve fund to finish the community room flooring (\$7,270). Emily seconded the motion. All in favor. A committee consisting of Kim, Sigh and Jim will meet to reassess and reorganize the projects for the capital reserve fund. They will report back to the Board at the April meeting.

- *Library Director Evaluation Process* – The Board will reassess the evaluation process at the April meeting.
- *Executive Session* – Library Director Evaluation – Emily made the motion to enter into executive session for the evaluation of the library director. Fran second the motion. All in favor.
Kim made the motion and seconded by Kim to leave executive session. All in favor.
The Assessment Committee will summarize in writing the sentiments of the Board. The summary will be shared with all members of the Board and Amy. The written summary will be added to the secretary's assessment file.
